## STALLHOLDER AGREEMENT

### 1. GOODS FOR SALE

- Tas Feline Inc. reserves the right to allow/ disallow stallholders to sell goods at the event.
- Products for sale or display should not be in competition with Tas Felines sponsor products.

### 2. STALL DETAILS

- All stall areas are 2m x 2m. If you require more space, please contact the Tas Feline Inc. Show Secretary **PRIOR** to Bump In to discuss requirements. Additional charges may apply.
- Tas Feline Inc. will supply tables and trestles.
- Stallholders or their agents are required to occupy and attend their stalls at all times.
- Stallholders must provide their own POS or EFT facilities should they require them.
- No power will be supplied for stalls at any Tas Feline Inc. show venues.
- Stallholders are required to Bump In before the start of judging at any show if located in the hall being used for judging.
- Stallholders can only dismantle or pack up theirs stalls during a show, if the stall location is outside of the hall where judging occurs. Closed stalls in the hall where judging occurs must have covers over all product. Packing up MUST be done silently in any location during a show.
- You are required to set up your stall in the most attractive way possible and keep it, and your stall area, safe and tidy at all times. It is up to the discretion of the show management in regards to the removal of any unsightly equipment or inappropriate signage.
- The location of all stalls is pre-determined prior to Bump In and will be allocated prior to your arrival. The location is to the total discretion of Tas Feline Inc. show management.
- Stallholders must comply with directions from the show management at all times.

### 3. RUBBISH REMOVAL

- ALL Stall holders are responsible for the removal of ALL their rubbish and general waste. Recycling and a sustainable attitude compulsory.

### 4. CANCELLATION & REFUND POLICY

- No refunds will be given if the Stallholder does not attend the show on their own accord for any reason.

### 5. ACCEPTANCE OF TERMS & CONDITIONS
